GENERAL DIRECTIONS AND GUIDELINES

In order to qualify for an F-1 student visa and I-20 through the US Citizenship and Immigration Services (USCIS), COA requires that students complete <u>two</u> forms (College of the Atlantic Financial Certification of Finances form and College of the Atlantic Financial Aid Application for International Students) <u>and</u> supply all relevant supporting documentation* that can corroborate information provided on the application forms.

ALL documents MUST be translated to English and US Dollars.

Please answer all questions to the best of your ability and <u>do not leave any answers blank!</u> If appropriate, enter "N/A" (not applicable) or \$0. These forms serve as legal documents, please feel free to contact us if you have questions before signing. Note that **figures are requested in US Dollars** and that you are asked to supply a currency conversion figure on which you base your calculations.

If your parents are divorced, separated, or not married and living separately, please complete two sets of forms, one with each parent's information listed separately.

*Documents may include but are not limited to:

- National tax return
- Annual earnings statements
- Letter/pay slip from employer
- Bank account records
- Asset statements
 - Business/Farm/Corporate/Partnership tax documents
